After leading the group in a pledge to the United States Flag, Chairman Walker asked for any comments from the public.

Public Comments.

Mr. Stafford commended the Supervisors, especially Chairman Walker, for the work on the proposed Unionville Regional Comprehensive Plan. The public hearing on the proposed plan will be held on Wednesday, April 6, 2011 at 7 p.m. at Patton Middle School Auditorium.

Minutes of February , 2011. By unanimous vote (5-0), the Supervisors approved the minutes, as prepared.

Onix Group – Amendment to Conditional Use Order. This was postponed until the April 4, 2011 Board meeting.

Conditional Use Application for a Bank Site on Route One at Schoolhouse Road. The Board set March 30, 2011 at 7 p.m. as the time for the hearing.

Unionville Regional Comprehensive Plan. The Public Hearing on the proposed plan is set for Wednesday, April 6, 2011 at 7 p.m. at Patton Middle School Auditorium. The three participating municipalities are East and West Marlborough, as well as Newlin Townships. Following the public hearing, each municipality will hold a separate public meeting to consider adoption of the Plan.

By a vote of 4-0, with Mr. Caudill abstaining, the Supervisors directed the Zoning Officer to issue a zoning enforcement notice to the Unionville-Chadds Ford School District for non-compliance with the zoning ordinance regulation regarding building height and to advise that relief can be requested via a variance request before the Zoning Hearing Board.

Certificates of Appropriateness. By vote of 4-0, with Mr. Caudill abstaining, the Board approved the HARB recommendation for Appropriateness for the following two properties in Unionville:

Pelet Property – 1635 W. Doe Run Road – approval to rebuild rear addition and to replace the front porch.

Provinski Property –Buffington Street – Approval to add a shed addition to the barn.
